

PROCLAMATION OF ELECTION

Oklahoma State Republic

Established 1907

By We the People of the Oklahoma State Republic, Established 1907

Part I — Proclamation of Intent

We, the People of the Oklahoma State Republic, affirm that the foundational governance of Oklahoma was established upon statehood in 1907.

We further note that successive amendments, statutes, and government actions have, in the view of the People, departed from the principles of republican governance with proper checks and balances. This has resulted in a state burdened with corruption, fraudulent elections, financial waste, unlawful actions, and more.

Accordingly, we declare our intent to restore the foundational structure of a republican form of government. Under this proclamation, we assert that all unconstitutional amendments and actions contrary to the People's authority are nullified. We will hold a lawful general election on March 31, 2026, through voluntary, county-based assemblies referred to as Committees of Safety. The interim officers elected in this election will occupy the seats of the Oklahoma State Republic and remain subject to future elections and ratification by the People.

This election shall proceed in alignment with these foundational documents:

- Constitution for the United States of America (1787)
- Bill of Rights (1791)
- Declaration of Independence (1776)
- Proclamation of Claim and Interest of the Republic for the United States of America, Oklahoma March 31, 2026d
- The Holy Bible
- Foundational documents of the Oklahoma State Republic

Part II — 2026 General Election for Interim Oklahoma Republic Governance

We the people of Oklahoma have stood up 7 counties for Oklahoma free State Republic which is 1 county above the number of counties when Oklahoma became a state. We, the people of Oklahoma will select interim officeholders to serve under the principles outlined in this proclamation. The prepared ballots

will be distributed to the delegates of the county assemblies, Committees of Safety including interim placeholder with completed ballots due on March 31, 2026.

The election notice to the People will be emailed and posted in county-based assemblies in advance of the election, including Oklahoma free State telegram room. After the election, each county's 2 delegates will report results to the interim Secretary of State and recorded during a live zoom call with a minimum of 2 witnesses, as well as published in the business forum telegram room (Oklahoma free State). Results shall be publicly reported within two weeks after the election on the designated Public Notice channel, truthsocial.com.

We the People of Oklahoma shall conduct a general election on March 31, 2026, to select interim officeholders to serve under the principles outlined in this proclamation. Prepared ballots will be distributed to members of the county delegates including current interim placeholders, with completed ballots due on March 31, 2026.

This Election Notice to the People will be emailed to and posted in county-based Committees of Safety, or Assemblies 10 days in advance of the election. After the election, each county's assembly will report its results to the interim Secretary of State and in each county's assembly subgroup on our business forum telegram room. Results shall be publicly reported within two weeks after the election on the designated Public Notice channel.

State Offices to Be Elected

1. Executive — Governor
2. Legislature
 - House of Representatives
 - Two Senators
3. Judicial
 - Three Justices
4. Secretary of State

Part III — Future Constitutional Convention

We the People recognize that Oklahoma's founding documents did not address certain later-arising civil rights developments, including universal suffrage regardless of race or gender. Such matters, and other necessary reforms, shall be addressed in a future Constitutional Convention convened in accordance with lawful constitutional processes.

Reservation

Nothing herein waives any right, concedes jurisdiction, or limits the People's continuing authority to govern themselves. All authority remains with the People.

We the People of the Oklahoma Republic, as witnessed below, are of legal age and sound mind to execute this Proclamation, do hereby declare the following:

1. My domicile is within the Oklahoma Republic of this PUBLIC NOTICE posting.
 2. This Proclamation of Election was attested to within the Oklahoma Republic on March 31, 2026.
 3. I do hereby declare and decree that this information is accurate and true.
 4. I therefore declare that I am Free, with explicit Reservation of All Rights, Without Prejudice, Non-Assumpsit, Non-Domiciled, Non-Resident, Non-Person, without the United States 28 USC 1746 (1).
 5. I do hereby declare that I agree with the initiation of the Proclamation for the Election of Interim Placeholders for the Oklahoma Republic as set forth above.
